Booking Terms and Conditions

Trip Price Policy:

A deposit of \$500 is required to secure your Overland Track Permit and the Rafting Deposit (if applicable). The balance of the trip payment will be due 60 days prior to departure. A late payment fee of \$100.00 will apply for payments made after this date.

Payments can be made by cheque or by electronic bank transfer. You will be sent a tax invoice 30 days before payment is due, which will include payment details. Price is subject to change up until final payment is made.

Trip price does not include: Flights to Launceston and return from Hobart, excess baggage charges, meals not specified as being included, drinks, insurance premiums, telephone charges or any other personal expenses incurred by participant, including cost of medical treatment if not covered by travel insurance. Parks Tasmania will cover the cost of Medical Evacuation in the event of an emergency.

Cancellation Fees

The \$500 deposit is non-refundable.

The balance of the trip payment is 50% refundable up until 60 days before trip departure, after which the cancellation fee will be 100% of the trip payment.

Rafting – Terms & Conditions of Booking (applicable to rafting participants)

Please refer to the Terms & Conditions for 'Water by Nature' which must be signed in addition to this form. Water by Nature require you to sign a separate Risk Waiver Form prior to commencement of the rafting phase of this trip.

Travel Insurance:

We recommend that you purchase travel insurance to cover you against loss or damage to baggage or personal property and to cover you in the event that you have to cancel your booking due to illness or extenuating circumstances within the 60day cancellation period. Risk Awareness / Liability Waiver

You have been advised by Free Spirit Adventures (FSA) and Water by Nature Tasmania (WBNT) that travel, trekking and rafting are inherently dangerous activities. You may be killed, injured, incapacitated and experience pain, illness and suffering. You may experience loss, damage or theft of my property. Any of the above may not be FSA or WBNT's fault or the fault of anyone. These incidents may be caused by others in your party, employees or directors of FSA or WBNT, their subcontractors or may be caused by environmental factors, or even just physical or mental exhaustion which can happen at any time on your trip. There is no way of predicting all the hazards you may face. While FSA and WBNT will take reasonable precautions to minimise the risks, there is no way FSA and WBNT can guarantee your safety on this trip 100%.

You acknowledge that the areas we will be travelling in Tasmania are remote with little or no immediate medical support. Your guide may need to begin first aid appropriate to the remoteness of the area and the nature of my ailment. By ticking the appropriate box on the Booking Form, you certify that you have read and understood these risks and they are acceptable to you.

You also agree not to seek compensation, financial or otherwise from any incident that might occur during or associated with the trip, from FSA or WBNT, its directors, officers, employees or subcontractors.

FSA, WBNT and their agents including employees, guides, and subcontractors shall not be liable for loss, death or injury, to any of its clients or loss or damage or delay to their baggage, personal effects or other property arising from the following:

1. Acts of God including but not limited to Landslides, Ice Cliff Collapse, Avalanche, Earthquakes, Flooding and Fire;
2. Civil disturbances of any nature.
3. Environmental Factors such as changes to trails, rivers and valleys, loose rocks, unstable ground, bad weather;
4. Any other circumstance beyond our control and responsibility.
